

Business Accounts: Required Documentation and Information Sole Proprietorship ☐ Valid tax identification number for the business (SSN or EIN) ☐ Internal Revenue Service documentation: - If using an EIN, letter or printout from the IRS, or copy of prior year filed tax return, showing the EIN and business name. ☐ One of the following: - Current Business License/Registration/Permit - State of New Mexico Taxation and Revenue Department Registration Certificate AND current Business License/Registration/Permit. - If business is in a rural county that does not issue a business license, contact Quality Assurance for assistance. ☐ Valid government-issued photo identification for each signer ☐ Valid social security number for each signer The Business Membership Signature Card must be signed by all authorized signers before the membership can be opened. **Limited Liability Company (LLC)** ☐ Valid tax identification number for the business (EIN; or SSN/EIN for Single-Member LLC) ☐ Internal Revenue Service documentation: - If using an EIN, letter or printout from the IRS, or copy of prior year filed tax return, showing the EIN and business name. ☐ Valid government-issued photo identification for each signer ☐ Valid social security number for each signer ☐ Filed Articles of Organization and, if applicable, any amendments. ☐ If not included in the Articles of Organization, Operating Agreement specifying who is authorized to establish membership on behalf of the LLC. LLC must be registered and in good standing with the New Mexico Secretary of State (SOS). ☐ The Business Membership Signature Card must be signed by all authorized signers before the membership can be opened. Business Accounts: Required Documentation and Information <u>Partnership</u> ☐ Valid tax identification number for the business (EIN) ☐ Internal Revenue Service documentation showing the EIN and business name (e.g., letter or printout from IRS, or copy of prior year filed tax return) ☐ Valid government-issued photo identification for each signer ☐ Valid social security number for each signer ☐ Filed Partnership Agreement If not included in the Partnership Agreement, Partnership Resolution specifying who is authorized to establish membership on behalf of the partnership. The Business Membership Signature Card must be signed by all authorized signers before the membership can be opened. Corporation ☐ Valid tax identification number for the business (EIN) ☐ Internal Revenue Service documentation showing the EIN and business name (e.g., letter or printout from IRS, or copy of prior year filed tax return) ☐ Valid government-issued photo identification for each signer ☐ Valid social security number for each signer Filed Articles of Incorporation and, if applicable, any amendments. If not included in the Articles of Incorporation, By-Laws or Corporate Resolution specifying who is authorized to establish membership on behalf of the corporation. Corporation must be registered with the New Mexico Secretary of State (SOS) and must be Active and in Good Standing with the SOS. The Business Membership Signature Card must be signed by all authorized signers before the membership can be opened. **Organization** ☐ Valid tax identification number for the organization (EIN) Internal Revenue Service documentation showing the EIN and organization name (e.g., letter or printout from IRS, or copy of prior year filed tax return) Valid government-issued photo identification for each signer ☐ Valid social security number for each signer Documentation about the Organization (Charter, By-Laws, Minutes, Letter, etc.) specifying who is authorized to establish membership on behalf of the organization Organization Authorization to Open Account and Transaction Agreement (credit union form) listing individuals authorized to transact, and signed by an authorized individual. ☐ If an Albuquerque Public Schools (APS) organization, a letter authorizing the use of APS tax identification number (EIN) is required. The Business Membership Signature Card must be signed by all authorized signers before the membership can be opened. Additional documentation may be required.
